25/14/1 **Highways** The reported potholes had been marked but not mended. The Clerk to contact OCC again, The sign by the 5-turns has not been mended. The village map is in the hands of the SCA. The road sign in Malthouse Lane has been replaced & the Council has been asked for the signs where The Green joins Cooks Hill be replaced also. This was agreed
