TOWN AND COUNTRY PLANNING ACT 1990 – ORDER UNDER PARAGRAPH 3 OF SCHEDULE 9 OF 1990 ACT AND REGULATION 26B TOWN AND COUNTRY PLANNING (ENVIRONMENTAL IMPACT ASSESSMENT) (ENGLAND AND WALES) REGULATIONS 1999 (AS AMENDED) PROHIBITING THE RESUMPTION OF THE WINNING AND WORKING OF MINERALS FROM LAND IN THE VICINITY OF SHENINGTON, OXFORDSHIRE.

I am directed by the Secretary of State for Communities and Local Government to refer to your letter of 6 October 2011, with enclosures.

Oxfordshire County Council had made an Order prohibiting the resumption of the winning and working of minerals on land in the vicinity of Shenington. The Statement of Reasons provided in support of the above Order states that it was made in accordance with Regulation 26B of the Town and Country Planning (Environmental Impact Assessment) (England and Wales) Regulation 1999.

Having carefully considered all the information submitted, the Secretary of State is satisfied that it would be appropriate for him to confirm the Order.

A copy of the Order and map duly endorsed with the Secretary of State's confirmation is returned herewith. I would be grateful if you could inform all those parties with an interest in the Shenington Romp Land.

WHEREAS

- (i) In respect of the land shown outlined in red on the plan attached at Schedule Two ("the Shenington ROMP"), on 28th February 1957 planning permission was granted for permission to win and work minerals.
- (ii) It appears to the County Council as Mineral Planning Authority that Regulation 26B of the EIA Regulations 1999 (as amended) applies in that:
 - a. A period of two years beginning with the suspension dates (16th November 2000 and 27th October 2008) has expired; and
 - b. The steps specified in regulation 26A(17) have yet to be taken.

NOW THEREFORE the County Council as Mineral Planning Authority hereby makes the following Order:

1. On the date this Order takes effect the resumption of the winning and working of minerals on the Land as permitted under the above permission is prohibited.
