#### Notes to accounts -

**General Receipts** – Planned Giving at £10397, including tax reclaimed and some envelope donations, has covered ministry and benefice costs thanks to the generosity on a small number of regular donors. Other Giving £2365 includes collections, sundry donations, £510 for memorial services, £387 re-imbursement of retired clergy fees, an energy grant of £250 and church box. Fees of £2780 came from a cremation service, a funeral, an interment of ashes and memorial installation and three weddings: a % of these are paid to the Diocese. Fund Raising £755: £285 Lent Lunch, £120 Christian Aid and £350 Harvest Supper. £150 came from the Illuminate & Celebrate Initiative. £1700 of general income has been used to cover church insurance via the Restoration Account.

General Payments – Donations £1250: £120 Christian Aid Collection part of £355 raised in the village, £635 Katharine House Hospice (Lent Lunch & Harvest Supper), £160 Children's Society (Messy Church & Carols Collections), £100 Shutford News, £160 Royal British Legion (Remembrance Service & Poppy Wreaths - inc £20 from SPC) £50 Deddington Brass and £25 OHCT. Ministry costs were £8539, the retired clergy fees refunded by the benefice. Total general payments £3459: costs as listed with Sibford Road Churchyard extention maintenance paid by Parish Council. £552 Electricity 11 months only. Maintenance costs include fire extinguisher check and altar curtain replacement. Admin/Sundries: £190 Deanery expenses, £108 Christmas Cards, £340 organist fees covered by fees above, £120 Hall Hire, £100 Lent & Christmas Booklets, £289 stationery, printing, postages and £208 worship & outreach costs. Cleaning materials, refreshments and flowers have been given by various people, with no labour charge for churchyard grass cutting. There is a surplus of £3444 increasing General Funds to £24613

Restoration Receipts – £2600 - Donation £100, £1200 Rootes/Waller Memorial Collection, £500 Illuminate & Celebrate and £800 Shutford Festival. £381 came fom CBF interest. Payments of £2040 for the building insurance premiums and £695 for the 5 year electrical inspection fee. Fixed Interest Investment valued at cost £10000 (market value £8931 a paper loss of £1069 at year end which will not be realised until investments sold).
